



First Meeting of the ICCAR Global Steering Committee

17-18 April 2016, Bologna, Italy

Decisions of the Global Steering Committee

Decision 1: The Global Steering Committee decides to align its name and mandate with contemporary development agendas and in response to evolving opportunities and challenges.

Decision 2: The Global Steering Committee decides on a new name:

International Coalition of Inclusive and Sustainable Cities (ICISC)

effective as at 1 June 2016, and will communicate this decision to all Coalition members.

Decision 3: The Global Steering Committee decides to launch a call for a global logo design contest among youth.

Decision 4: The Global Steering Committee asks UNESCO to approve a new logo with the new name.

Decision 5: The Global Steering Committee members agree to ask each Region to discuss if there is a need to review their 10 Point Plan of Action in alignment with the 2030 Agenda (specifically the SDG#11) and the *New Urban Agenda*, to be adopted in Quito in October 2016.

Decision 6: The Global Steering Committee decides to have a strong ICCAR presence in Quito and will therefore provide the ICCAR Secretariat with a list of all cities planning to attend the Habitat III Conference.

Decision 7: The Global Steering Committee agrees to the production by each regional/national Coalition of a short regional perspective paper, to be included in the UNESCO portfolio for Habitat III. The papers would be produced no later than 31 July 2016.

Decision 8: The Global Steering Committee decides to mobilise all regional/national Coalitions and relevant networks to contribute to the UNESCO Virtual Exhibition for Habitat III, soliciting materials and information, and communicating across all relevant platforms.

Decision 9: The Global Steering Committee confirms the participation of each regional/national Coalition in the development of a UNESCO data initiative. The Committee agrees to share details with the ICCAR Secretariat of how it could contribute to and/or support the initiative by May 2016.

Decision 10: The Global Steering Committee agrees to attend the UNESCO Expert Meeting in Nairobi to develop a *Guide for promoting enabling environments for city-level action on inclusion – towards good practices*.

Decision 11: The Global Steering Committee agrees to develop and implement a programme with strategic partners to work with sport and cultural leaders and celebrities to actively mobilise resources and promote the vision and programmes of the Coalition.

Decision 12: The Global Steering Committee approves its Terms of Reference.

Decision 13: The Global Steering Committee approves and adopts the Bologna Declaration.

Decision 14: The Global Steering Committee agrees to hold annual meetings in one of the lead member cities and an additional meeting at UNESCO Headquarters. Mayors or their designated representatives convene between physical meetings, enabling the Committee to continue leading its work through virtual means such as telephone or video conference.

Decision 15: The Global Steering Committee agrees to facilitate the launch and/or update of a website for each regional/national Coalition.

Decision 16: The Global Steering Committee agrees to request all Coalition member cities to install visible Coalition membership plaques in town halls once the new logo is approved by UNESCO (pending decision 4).
